While this is a work in progress, we are hopeful that we will be able to expand to at least one DCCCD campus located in an area where voter turnout is disproportionately low. We hope that if voting centers are in a more convenient place, community college students will be more likely to vote.

What are the changes in administration for Fair Park recommended by the Mayor's Task Force? (The City Council will vote on this plan in early September.) What oversight will the City of Dallas have over the proposed Fair Park Texas (FPT) Foundation? What sort of public reporting will be implemented? A physical plan for the park exists. Will the new FPT Foundation follow this plan or seek more community recommendations before proceeding with physical changes? Was there a fair request for proposal (RFP) for the firm to draw the Fair Park design?

How closely did the surrounding community members participate in developing the plan? How will the plan improve Fair Park, the neighborhood surrounding it, and the city? How do the 16 existing non-profit entities such as the State Fair of Texas, Inc., Dallas Historical Society, African American Cultural Center, etc., fit in the new management structure and the physical plan? Are there efforts to inform the voters through the entire planning process? What is the financial plan to pay for current and future operations and maintenance?

## FAIR PARK—WHAT'S THE BIG DEAL?

For several months the news has included mention of a plan to revitalize Fair Park. Why is Fair Park an issue? How can the site be best used now to benefit everyone in the community?

A little history tells part of the meaning of Fair Park originally and for the future. Darwin Payne reports in *Big D* that the Fair Park site started originally as an Army facility, Camp Dick, which had pre-flight training for men who could then transfer to Love Field for actual flight training. The Chamber of Commerce frequently sponsored visiting air shows there in the early days.

Then the big idea of having a centennial anniversary of Texas' independence, first suggested by Governor James S. Hogg in 1903, began to take shape in Corsicana in 1923 at a joint meeting of the Texas Press Association and the tenth district of the Associated Advertising Clubs of America. What Dallas lacked in history, it made up with two hundred acres of land suitable for the centennial site, provisions for the utilities to the site, and submission of a monetary offer with an inventory of all properties available. Robert Lee Thornton, president of his own bank and an enthusiast of state fairs and world expositions, campaigned for Dallas to host the centennial, aided by Nathan Adams of First National Bank and Fred Florence of Republic National Bank.

Dallas won the bid for the event over Houston and San Antonio with a \$7.8 million bid. The Centennial opened on June, 6, 1936, with more than 250,000 spectators witnessing the inaugural parade. It was broadcast across the nation over two radio networks. President Roosevelt visited the centennial and proclaimed that "the Centennial Exposition was not just for Texans but for the people of all the other forty-seven states as well."

Darwin Payne, the source of this limited report, states that the Centennial was the "crowning achievement in all its years of self-promotion. The PR was invaluable. While the fair itself lost money, hotel, restaurant, wholesale sales, and local bank deposits all benefitted. A total of 6,353,827 people attended before it closed. The buildings at Fair Park are said to be the finest collection of Art Deco architecture anywhere in the world.

**Fair Park has had a significant meaning in the past; so how can it have a more significant meaning in the future?**

From the beginning Fair Park was treated as separate and apart from the adjacent neighborhood. Parking is a sore point as the City used eminent domain to secure land for more parking in the 1960s. The Art Deco buildings are in

poor condition and greatly need repair before they deteriorate even more. In addition, African Americans could only attend the fair on one day during its three week run until the late 1960s.

To complicate matters even further, there are questions about the Parks Department oversight for Fair Park and the various organizations that use it, especially the State Fair of Texas, which is the largest user of Fair Park. Attendance has increased significantly in the last few years with 2.5 million people attending in 2015 and paying \$53 million for coupons, \$11 million more than its previous record year. Yet, attendance data and financials have been questioned.

Any attempt to revitalize Fair Park must look at a number of factors. Some have demanded greater transparency and input from the neighborhoods before any changes in the management of Fair Park are realized.

- Can Fair Park become a destination place like Central Park in New York City, Balboa Park in San Diego, or Millennium Park in Chicago?
- How can Fair Park be made to feel more welcoming and inviting?
- What should the relationship between Fair Park and the neighborhoods surrounding it be? Some think any bond issue to improve Fair Park must also include improvements for the surrounding area.
- What is the purpose of Fair Park other than to provide a site for the State Fair?
- What is the role of the State Fair in the mix of activities during the year?
- How can it best be managed?
- How can 16 different non-profits in Fair Park be managed for an overall benefit to the city, the neighborhood and the Fair Park site? Or is it possible to have a foundation run it and be accountable to the city?
- How can the Art Deco buildings be repaired and refurbished without costing the City of Dallas considerable expense?
- Can Fair Park attract entities to rent the available buildings and refurbish them?
- What sort of oversight by the City, the City Council and the public is appropriate and effective in monitoring the proposed nine-member Fair Park Foundation Board that would manage and renew Fair Park and who selects the board members?

Come to the general meeting on September 29 to ask your questions and get a better understanding about why bother with Fair Park.

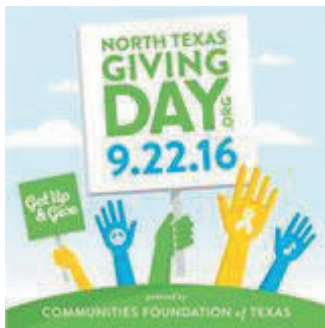
