Advocacy 101 – from League Texas Chair, Elisabeth MacNamara 2/1/23

GENERAL GUIDELINES

- The League speaks with one voice at every level
 - Maximizes impact of member voices
- Only the president speaks or designates someone to speak
 - Issue chairs speak for the League by designation of the Board
- The League speaks from positions developed through consensus
 - Study and consensus process is designed to make leaders and members comfortable speaking to issues from the same point of view
- One membership-Three levels- Three lanes
 - LWVUS speaks to Congress, LWV Texas to the Legislature and Local Leagues speak to local officials.



NONPARTISANSHIP

- The League never supports or opposes candidates or parties
 - Since its inception in 1920, the League has maintained its nonpartisan policy regardless of what the law allows.
- The League speaks to issues only
 - In a polarized political space issues are viewed through a partisan lens.
 - The League develops its position over time based on member study
- Our nonpartisan stance distinguishes us from other organizations, often including partners
 - Many trusted partners endorse candidates which impacts what common strategies we can endorse

ADVOCACY VS. LOBBYING


- Advocacy is educational even if only one side is presented
 - Issue Forums that educate the public on a League position
 - Policy Papers such as Action Papers that present the League position
- Lobbying is support or opposition for specific pieces of legislation
 - Asking a legislator to support or oppose legislation in person or in writing
 - Issuing an Action Alert to our members and supporters taking a position on a specific bill or action by the Legislature
 - Communicating the League's position for or against a ballot measure






