#### In general

- Voters should perform a Self-Assessment before going to a polling location for signs or symptoms of possible COVID-19.
- Voters exhibiting any of the known symptoms of COVID-19 should consider curbside voting.
- Voters should consider bringing their own marking instruments such as a pen, pencil with eraser, etc.
- Voters should consider wearing their personal cloth face covering when entering the polling place.

- The voter should be prepared to lower or remove their face covering when checking in if the election judge is not able to determine identity while wearing a face covering.
- If a voter contracts COVID-19 or other condition that prevents the
  voter from appearing at the polling place on election day without
  a likelihood of needing personal assistance or of injuring the
  voter's health after the deadline to submit an application for a
  ballot by mail, the voter should contact Dallas County Ballot by
  Mail at 214.819.6364 for details about submitting an Application
  for Emergency Early Voting Ballot.

# **Eligibility for Voting**

You must be a citizen of the United States, registered to vote in the county of your residence 30 days prior to election day, and must be at least 18 years old on election day. You cannot vote if you have been declared by a court exercising probate jurisdiction to be totally mentally incapacitated or partially mentally incapacitated without the right to vote or are a convicted felon who has not completed your sentence, probation and/or parole.

## **City of DeSoto Special Election**

The City Council is the governing and lawmaking body of the City of DeSoto and consists of a Mayor and six Councilmembers. All are elected at large, by qualified voters of the entire city, and members must reside in the district they represent. The Mayor represents the city as a whole and is not required to live in a particular district. If no candidate receives at least 50% of the votes, there will be a runoff election.

City Council are open to the public and are held on the first and third Tuesday of every month at 7 p.m.at City Hall.

**BUDGET:** Should the city be faced with a budget constraint due to COVID, one of the initial measures I would suggest would be to look at cutting a percentage of the budget across each department. The reason for this is that is, it causes departments to "trim the fat" and it forces you to look for ways to be more efficient in how you operate. I've seen many times that when faced with making those choices, you can operate on less than you think you can and realize savings as a result of it. Also, something else that I would consider is looking at positions of retirees or employees who quit and evaluate each of those positions in terms of necessity before filling that position again. Reducing services or raising the tax rate is currently not ideal and I would only consider that as a last resort should all measures attempted before not be enough to get us through the constraint.

**DEALING WITH THE PANDEMIC:** During this unprecedented challenge of the current pandemic, the city would need to first proactively lobby for as much in Covid relief dollars as possible. These dollars would need to be provided to residents impacted by job loss and used for housing and utility payments. The city could also work with Landlords to provide an eviction moratorium in return for some tax incentives. With the increase in banks investing in minority-majority areas and initiatives, the city could meet with bank leaders to establish business loans specifically for DeSoto business owners that would increase jobs while investing in our own. Housing and jobs are the two areas that have been hardest hit and addressing these areas will have a positive impact on other issues throughout the city caused by the pandemic.

AFFORDABLE HOUSING: I'm in support of providing a variety of housing options for residents. Many cities have found that there are millennials and single adults who look over their city because the only housing option is a single-family home and they aren't either financially at that point or simply aren't interested in ownership at that time. For them, a townhome or apartment is more in line with their current lifestyle. Some travel for work or don't want to worry about the upkeep of lawns, etc. that apartment and townhome living doesn't require. I am in support of quality, high end, affordable apartment and townhome developments to provide that option to our citizens and those who may desire our area but don't see the variety of choices for housing in neighboring cities. To ensure accountability standards, we can put registration processes in place for apartment owners and landlords. This also provides another stream of income to our city that could be reinvested into the city in creative ways PUBLIC SAFETY: I believe that our city currently has done a good job in the area of public safety but there is always room for improvement. We need to provide greater coverage and presence across the city. I would also work to help initiate the process of forming Neighborhood Associations for those subdivisions without a Mandatory/Voluntary HOA already in place. This way, communication can be further strengthened between residents and the police and fire departments. These types of initiatives pay huge dividends and don't cost a thing. As far as increasing the numbers of police as has been suggested by some that would cost to not only recruit but to retain qualified candidates by matching industry compensation plans. This would require an in-depth look at the budget to first determine areas where we could reduce spending without impacting services to see what dollars could be reallocated to police recruitment and salaries.

**CHALLENGE/OPPORTUNITY:** The greatest challenge and opportunity in the next several years will be the pandemic because its impact will be far-reaching into our future. It is incumbent upon us to look at this through a multifaceted lens. From the impacts on our residents following unemployment or underemployment to the academic slide of our students this pandemic is going to play a role in our decision making for years to come. This challenge is also an opportunity to come together as a whole and make strides that will serve as an example of what a city can do when they decide to work together on their collective issues.

**BUDGET**: As small business owner in DeSoto, I've been balancing budgets for over 30 years. As a DeSoto council member and the Mayor Pro-Tem, We must realize cost savings through attrition and be creative with remote work options that reduce administrative expenses. We can strategically use our strong fund balance to maintain city services and avoid raising taxes at all costs. Also, our E-Commerce business has generated more revenue for our city which has off- set the lost of revenue from hotel revenue fund(HOT Fund).

**DEALING WITH THE PANDEMIC:** I'm a strong advocate for using COVID Relief funds to directly impact our citizens, businesses and neighborhoods. I support direct grants to small businesses in DeSoto. **PUBLIC SAFETY:** I believe our performance in public safety has been generally strong. But there is always room for improvement. We must focus on proactive crime prevention, and ensure officers are visible in our neighborhoods and serving the needs of our citizens. But we must also expand public safety to include public health, particularly in light of COVID-19. That is why we have created a Mental Health Service Unit thru the (CARES Team) Public safety is the number one priority for the Mayor, and our budget must reflect this priority **CHALLENGE/OPPORTUNITY:** Our greatest challenge is restoring trust and increasing transparency. In all my years serving DeSoto - I have been open, honest and loyal to our community. I have never switched up, and I never will. **BUDGET:.**I would consider a hiring freeze first and try to avoid cuts in services. If that did not achieve a balanced budget, I would then review each department for specific ways to reduce costs. I would not want to impact our police, fire, and EMS departments. We are critically short of officers at the present so that would be off the table. Our recent survey, as of October 2020 confirms the highest rating of all departments are our police, EMS, and fire departments.

**DEALING WITH THE PANDEMIC:** DeSoto is dealing with the pandemic through the C.A.R.E.S. Federal government ac. and the Dallas County Emergency housing program (EHAP) designed to provide rapid, short term housing funding. It targets a population eligible through specific household and individual incomes. EHAP provides critical assistance if more families experience loss of income and face potential homelessness. I would ensure we are monitoring the success of our programs and follow-up to determine if sufficient assistance is provided to those who need it. We have to be proactive and vigilant in providing all available resources to our citizens. The city of DeSoto is working with our businesses though the Small Business Administration for those in need of grants. So far, a total of \$421k have been awarded to businesses. Also, for food pantries a total of \$76k was awarded. We have to continue to take advantage of all resources and programs, let our citizens know what is available and assist them in getting it.

**AFFORDABLE HOUSING:** Since DeSoto is 90% built out, we have nowhere else to build but up. I support apartments and townhomes but only within specific zoning approved areas. I would suggest they be built bordered by a utility easement or land border. For example, the Veloweb bicycle trail system area or 10 Mile Creek where there is a natural boundary and less likely to have HOA disapproval's. I would also consider rent assistance for police officers, fire department or city employees that live in the apartments.

**PUBLIC SAFETY:** DeSoto's recent survey released in October 2020 suggests the citizenry is 100% behind our police force and feels they are doing a good job. In the spirit of continuous improvement, I would propose we go back to community policing. That could include having one specific police officer in a specific territory. We can get the police officers to engage in the neighborhood and HOAs. I also suggest we help neighborhoods form or strengthen their current neighborhood watch programs. Police officers would attend these meetings to introduce themselves and specifically tell citizens what the crime statistics are and share preventative measures they can take. The community would see police cars patrolling their neighborhood and being accessible. Currently, DeSoto has started a program to be proactive in helping citizens with mental health issues get help. It is worse when a 911 call comes and the situation might be more heightened due to a mental health issue.

**CHALLENGE/OPPORTUNITY:** DeSoto citizens have longed for a natatorium and now it is on our 2021 Strategic Plan. Fortunately, with my background and experience on the DeSoto Park & Recreation Board, I have acquired knowledge of what that entails. I have visited several locations in the metroplex to get an idea of what a great complex should look like. Being on the city council I would be able to help my vision become a reality. Each natatorium I've researched includes positives and negatives. I would work to ensure we have one unique to DeSoto that fits our citizens needs. Some positive features could include a workout area and swimming areas. Extras amenities would be childcare availability for members, designated sections of the pool for children and adults, and birthday parties, as well as landscaping towards low maintenance or xeriscape properties. It would be a great achievement for the city to achieve this goal and improve the quality of life for our citizens.

**BUDGET:** Many readers may see this as a hypothetical question but I assure you it's not: it's not if the budget will experience a shortfall but rather when. As councilmember I would not support either a reduction in city services nor raise the tax rate. My reasoning is this: if the city find itself in a financial bind for operational funds, I must assume residents too are also experiencing greater financial difficulties. Therefore, arbitrarily adding additional expenses to the residential community would be a betrayal of ones fiduciary duty. In response to the short fall issue: as a councilmember I advocate maintaining a rainy day fund and/or a rolling reserve account to handle emergencies.

**DEALING WITH THE PANDEMIC:** Policies developed at the national level designed to contain the COVID-19 virus outbreak are well conceived but collaboration my local officials are vital to ensure success of policies. Efforts on the ground by local actors implementing and regulating guidelines regarding such mandates as mask, social distancing and crowd gathering will play a huge role in control and eradication of the virus. Finally, local officials must provide treatment sites to in sufficient numbers to accommodate the public.

**AFFORDABLE HOUSING:** Affordable Housing is a code phase for income inequality. As long as we fail to address the income inequality issue affordable housing shall continue to plague housing market and be a drag on the economy. With regards to growing pressures on affordable housing for city employee: the present pay scale structure of city employees is problematic. Therefore, the city itself is a contributor of the problem they allege to want to solve. As for as more apartments: I would be reluctant to support additional apartment construction because apartment dwellers do not have skin in the game if they are renters. Then, the question becomes how do we convert renters to homeowners? As a councilmember I would bring innovative business policies that would achieve homeownership for all city employees.

**PUBLIC SAFETY:** My observations regarding policing and public safety are yet to be substantiated and therefore I must reserve my thoughts on this topic until a later time.

**CHALLENGE/OPPORTUNITY:** It's difficult to address a problem without first acknowledging a problem exist. Throughout the entire election cycle much of the rhetoric has been about how great the city - DeSoto - i is doing. I suppose the objective is to camouflage the fact(s) that the school system is imploding, black-listed by industry who is hesitant to relocate within city boundaries, the city held hostage by political officials who are conflicted about their fiduciary responsibilities and on and on. As with any problem(s) there are opportunities to fix it. As a councilmember I am convinced that growing the economic base and creating economic development formation is the greatest challenge and opportunity before us. Accomplishing this objective would allow council to deliver a diverse mix of quality services to residents which allow DeSoto to "RISE AGAIN".
